Conditions

A 25% retainer is to be paid at the date of signing. This portion will be non-refundable if date is cancelled within 90 days of the performance date.

If performance (s) is/are outdoors and shelter is not provided, Props and Sound equipment could be damaged by rain. Wet surfaces increase the slipping risk with stilting and/or unicycling. Assessment of risk, and decision whether performances can continue will be reasonably judged by the performer. Remuneration will not be effected by show cancellations due to weather.

In the event of a show(s) being missed due to unavoidable circumstance such as injury to performer or Act of God, notice will be given to purchasee as soon as possible, and Proportionate value of performances missed will be subtracted from payment. If a circumstance that leads to a performance being missed is reasonably avoidable and/or the performer does not notify the purchaser, the proportionate value of the performance missed will be awarded to the purchaser by the performer.

It is the performer's right to limit audience video-taping of the show. Photography is permitted.

The Purchaser has the right to use photographs and or short non-sequential video-clip(s) (10 seconds maximum) of the performance for promotional purposes.

The Puppet Tamer Show/Tim Holland is covered by a 2 million dollar liability insurance policy. A certificate which specifically names the Purchaser can be provided if given enough notice.
